Freshtival CAMPSITE HOUSE RULES

- The house rules for the festival also apply for the campsite of the event. In addition, the following campsite house rules apply for holders of camping or camper/caravan tickets. In connection with the importance of compliance with the campsite house rules, these will also be posted in abbreviated form at the entrance(s) and on the campsite of the event for the campsite visitors. During the event, holders of camping tickets must strictly adhere to both the house rules of the event grounds and the house rules of the campsite.
- The house rules of the event grounds and the campsite house rules also apply for guests who rent a pre-prepared accommodation. The tenant of an accommodation with accessories remains responsible and liable for any damage to the rented property. Any damage to the rented property will be recovered from the tenant. In that case, any deposit will not be refunded. The organisation has the right to recover the actual damages if these are higher than the deposit.
- For admission and/or overnight stay at the campsite of the event, a camping ticket in combination with a weekend ticket must be ordered or purchased. A camping ticket in combination with a weekend ticket does not give access to the caravan/camper spaces, sponsor or VIP areas or backstage areas. On the other hand, holders of camping tickets in combination with weekend tickets have access to all other publicly accessible areas on both the campsite and the festival grounds during the opening hours of these separate premises. In order to be able to access the festival grounds, no separate ticket therefore needs to be purchased. A camping ticket cannot be exchanged (for other types of tickets) or returned (for money) to the organisation.
- Camping ticket holders are subject to the opening hours set for the event with regard to access to the campsite. The organisation expressly draws attention, also on behalf of the municipality and the police, to the ban on 'wild camping' and strongly recommends that campsite visitors only come to the event grounds during the applicable opening hours, so that they are not staying there earlier than or after the end of those opening hours.
- A minimum age of 18 years applies on the campsite, unless explicitly communicated otherwise by the organisation. The organisation is entitled to ask for identification. Campsite visitors under the age of 18 are also not admitted to the campsite under the supervision of an adult.
- Electricity connections are available at various locations on the campsite. Carrying your own power (generators etc.) is not permitted. Mobile phones can be charged at the designated charging points.

- For the use of your own tent, just one camping and weekend ticket (per person) is sufficient. There is therefore no need to purchase a special ticket for the tent, as is the case with caravans, trailer tents or campers. Only campers, caravans and trailer tents that meet the requirements set out in the Road Traffic Act and the Vehicles Regulations are permitted. (Temporarily) converted vehicles with a mattress in them are therefore not. The length of the caravan, camper or trailer tent is a maximum of 7 metres with a maximum weight of 12,000 kg. Gas installations with detachable gas cylinders in campers, caravans and trailer tents are not permitted. Only gas installations with fixed, non-removable and built-in gas tanks are permitted. For campers and caravans with such a fixed gas installation, a valid APK inspection report or a recent G607 gas inspection must be shown. If a vehicle is required to put the caravan or trailer tent in place, it must immediately leave the campsite again. A deposit may be collected to ensure that the caravan or trailer tent is also collected after the end of the event. If a deposit is collected, it will be refunded if the caravan or trailer tent leaves the campsite again on the Monday after the event. It is not possible to request the deposit back at an earlier or later time.
- Only for the transport of permitted camping equipment to the camping pitch may a 'Bolderkar', wheelbarrow or trolley that fits through the inspection gates be brought along. The dimensions of the inspection gates are listed on the website.
- Cars, motorcycles, tractors, mopeds, bicycles and trailers must be parked at your own risk in the designated car park, not on the campsite itself. Overnight stays in the car park are not permitted. The parking regulations further apply in the car parks. In the event of a violation, the visitor may be denied access to the event grounds by the organisation, and the police may be involved.
- Holders of camping or camper/caravan tickets must collect their own rubbish and take the tent and/or caravan, trailer tent or camper home with them.
- Only camping chairs and/or tables are allowed, provided they are taken home after the end of the campsite visit. Domestic appliances such as stoves/hotplates, microwaves, freezers and refrigerators are not allowed and are not admitted to the campsite; this also applies if they no longer function. The removal costs of all said equipment will be recovered from the offender.
- Open fires are not permitted; this includes torches, bonfires, fire baskets, fireworks etc. Loose gas installations, for example in campers, trailer tents and caravans, generators, fuel tanks and loose (lithium) batteries are also prohibited. Small disposable barbecues (for use at the barbecue spots) and camping gas cylinders (guideline: Campingaz 901 0.4 kg) and gas cartridges for camping cooking appliances <u>are permitted</u>.

- Tap installations, carbonated kegs and kegs of beer (larger than 5L) are not permitted.
 Self-tapping kegs of 5L are permitted, on the understanding that: the maximum quantity of drinks to be brought along per person is met. This quantity is listed on the website. Excess beverages brought along will be confiscated; the confiscated goods
 - will not be returned afterwards.
- Glass is not allowed on the campsite. Everything made of glass will be confiscated. Cans (with beverages) may not be taken from the campsite to the festival grounds. Spades, shovels and tools or toolboxes are not permitted and will be confiscated, with the exception of a (rubber) hammer to secure the tent.
- Graffiti, confetti, party poppers, paint etc. are not permitted.
- Excessive sound installations and megaphones are not permitted.
